**TERMS OF AGREEMENT**

Segment 2 consists of six (6) hours of classroom instruction. **For a student to participate in Segment 2, verification log must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months.** If a student is absent at any time during the class they must make up the classroom instruction on the same day as their absence during a following class (i.e. if a student misses the 3<sup>rd</sup> day of the class they would need to attend the 3<sup>rd</sup> day of the next available Segment 2 class).

**If student does not adhere to the following rules the instructor may deduct points or dismiss student immediately:** No swearing in class; Students will respect others and instructor; Students will follow instruction given by instructors; No sleeping or head resting; Bring pen and paper; Take notes; No talking while instructor is talking; No vandalism of property (anything destroyed will be student's responsibility and subject to be dismissed permanently from class with no refund.); Student must dress appropriately (if the student is not dressed appropriately he/she will be sent home and will have to make up missed time); Use of personal electronic devices is to be kept to an absolute minimum unless being used for classroom activities.

Segment 2 fee is \$50.00. **Cash only payments.** Replacement of lost Certificate of Completion fee is \$10.00. **Cash only payments.** Full payment is required at first day of class. The school, All About Driving, will not refund any fee, tuition, or charge or any part thereof should the school be ready, willing, and able to fulfill its part of the agreement. All About Driving reserves the right to cancel or reschedule courses or classes at its sole discretion.

**Passing Segment 2 course requires a score of at least 70% on State test. Student will be given up to two (2) additional attempts to pass the test.**
