Segment 2 consists of six (6) hours of classroom instruction. **For a student to participate in Segment 2, verification log must be received that the student has completed a minimum of 30 hours of driving (including 2 hours at night) with a licensed parent or guardian (or parent designee) on a level 1 license, which has been held for not less than 3 continuous months. If the student is absent from class, he/she must make up the classroom instruction missed by attending a following class covering the relevant material.**

If student does not adhere to the following rules, the student may be subject to dismissal without attendance credit or refund: No swearing in class; Students will respect others and instructor; No sleeping or head resting; No talking while instructor is talking; No vandalism of property (damage will be student's financial responsibility); Use of personal electronic devices is to be kept to a minimum.

Segment 2 fee is \$55.00. Replacement of lost Certificate of Completion fee is \$2.  
Full payment is required at first day of class. The school, All About Driving, will not refund any fee, tuition, or charge or any part thereof should the school be ready, willing, and able to fulfill its part of the agreement. All About Driving reserves the right to cancel or reschedule courses or classes at its sole discretion.

**Passing Segment 2 course requires a score of at least 70% on State test. Student will be given up to two (2) additional attempts to pass the test.**
